The supported schools will emphasize the development of leadership skills and proficiency in Spanish and English.

Program 2: Promising impoverished Guatemalan youth identified in Program 1 for their leadership and academic potential will be supported for advanced studies at Guatemalan high schools (diversificado) and universities. While in the the program, all students will sign contracts covering the conditions of their scholarships and the expectations for community service focused on improving the educational opportunities for their fellow Guatemalans (this last provision only applies to new students recruited after September, 2013).
